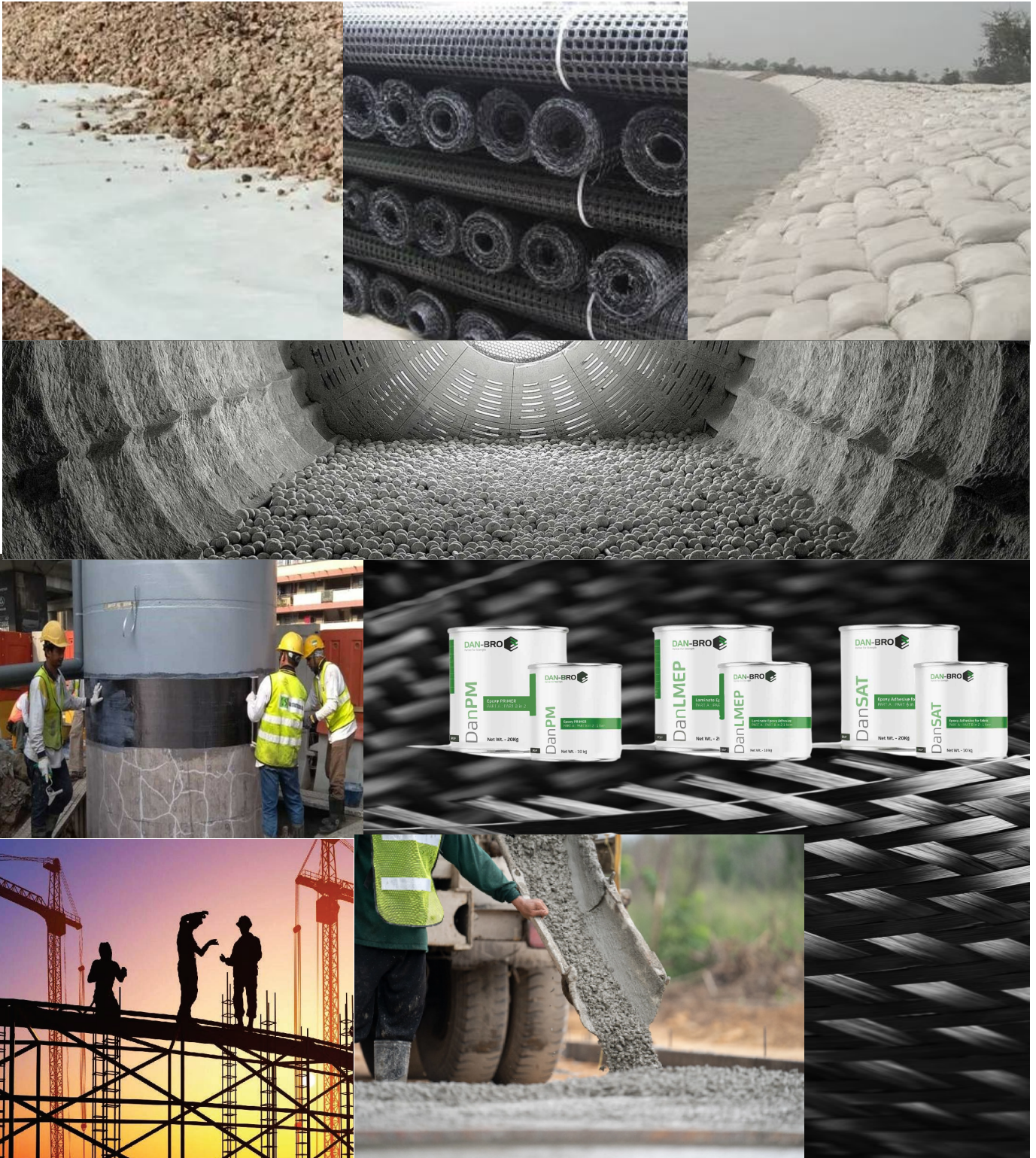

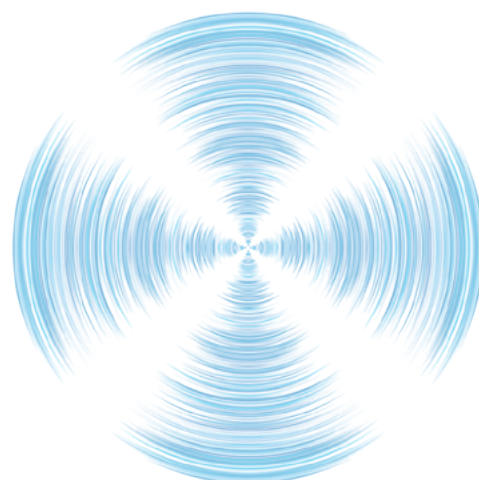

All companies of the Group come under the holding company structure but conduct business activities under their own name.

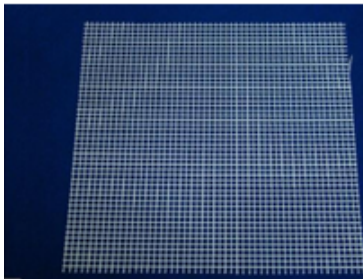
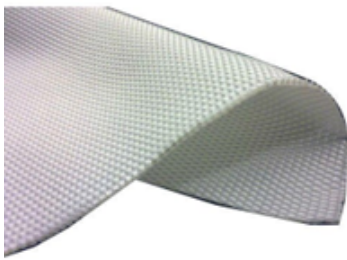
